

#### - FROM THE PRESIDENT -

As your new president I would like to say first that I hope all of you have had an enjoyable and interesting summer and I would like to welcome our new members who have joined over the summer months. However, the summer is fast coming to a close and South Shore is revving up for action. You will see many activities planned as you read our Newsletter.

During the past 4 years of our existence, South Shore Audubon has grown into a conservation organization of great activity and respect among other conservation groups and governmental agencies. This reputation was built by our two former presidents, Mr. Alvin Friedman and Mr. Albert Lemke, and with everyone's help I hope we will be able to maintain and strengthen this respect.

One of the basic goals of any conservation group is, of course, to protect our environment. While that is a very general statement and would include many specific sub-categories, there are a few ways this goal can be achieved, e.g. through education, economics or politics. Probably one of the most important and often the most immediate is through politics. This is a fact of life that cannot be ignored, and yet is an area that can be influenced by everybody! One of those ways is by letter writing. I cannot emphasize enough how important it is! Many times people feel writing a letter is a waste of time - you send a letter off and that's the end of it. Sometimes the matter is resolved in your favor, sometimes not. But you still have the feeling that your letter did not affect things one way or another.

Let me assure you that this is not so: Our officials pay very close attention to the tenor of their letters. One of the strongest, if not the strongest, weapons conservation groups have is the letters of people who are concerned. In order to develop a strong letter-writing campaign within our organization, I would like to set up an emergency letter hot--line. Everyone who will PROMISE to write a letter when I contact them on some emergency situation, please send me a postcard with his name, address and 'phone number. I will then set up a file for emergency use when I receive information that must be acted upon immediately and cannot wait for our Newsletter. This way possibly we can generate a handful of letters on important issues.

Some of you may be aware that our dues are going up effective September. Inflation doesn't escape anyone! I hope the extra few dollars will not cause anyone to drop when renewal time comes. More than ever we need your help in fighting many of the abuses to our environment. Please stay with us. The new dues schedule is listed in this Newsletter.

I, and all my fellow officers, look forward to working with all of you and hope that you will call or write us when the need arises.

#### LEGISLATIVE - CONSERVATION ISSUES

Our former president, Al Lemke, has been doing more than vacationing this summer, although he has done that, too. The following news from is the result of his efforts.

Letters do help:

#### Japanese Whale Boycott Bearing Fruit:

I have received a number of replies to my letter informing various Japanese firms (Newsletter, May 1974) of our support of the boycott of Japanese goods until the Japanese slaughter of whales is halted.

Every company, except one (HITACHI) expressed agreement with out concern and indicated they have relayed comments received (which apparently are quite numerous) to their parent firms. One (NISSAN MOTORS, makers of DATSUN automobiles) enclosed a copy of their letter to the Japanese Consul General in which they pointed with justifiable pride to their "Plant a Tree in a National Forest" program, indicated their environmental interest, and requested the consul to put pressure on his government to halt its depredation. The letter was dated February 28, 1974, indicating they have received previous communications on this subject.

The concern expressed by the various firms (except for Hitachi, which curtly stated that complaints should be addressed to the Japanese Whaling Commission) shows that they are worried. If we keep up the pressure they will in turn exert pressure on the Japanese government. Only in this way can we save the various species of these intelligent, harmless mammals from extinction.

#### Use of Natural Wolf Fur Protested:

It came to my attention through the June 1974 issue of "Defenders of Wildlife" that three concerns throughout the United States are manufacturing and selling in retail outlets Arctic "Snorkel" parkas with natural wolf fur trim on the hood. The writer of the letter in the magazine suggested an educational campaign might be in order since many people might buy these innocently.

Accordingly, I wrote to the concerns listed saying that many of our 1,000-member are bird watchers and are active in other outdoor activities; that I would recommend to the members that products from these concerns not be purchased until they discontinued the use of this fur, or that of any wild animal.

I received a reply from only one company - Schott Bros., N.Y.C. - which stated that they do not use natural wolf fur on their Snorkel Parkas anymore.

#### SUMMER ACTIVITIES OF OUR MEMBERS:

From Marge Fischer comes this entertaining article:

I feed the birds all summer. I enjoy watching the fledgelings flapping and squawking as their parents stuff pounds of birdseed down their gullets; I want to see who gets stuck with raising the cowbirds; and sometimes I get an unexpected bonus.

On the morning of July 3rd, as I opened the back door there was a flash of white. -- Too small to be a pigeon, and too quickly gone to be identified. A fast check through the bird books revealed no small white bird. Next morning, I looked <u>before</u> opening the door, and sitting in the rose bush was the white bird, being fed by a perfectly ordinary male house (English) sparrow! He was pure white, except for a tinge of cream shading the wings; legs and bill pale yellowish tan, much lighter than the usual sparrow color, eyes startlingly dark.

Now to get a picture! He was a regular at the feeder until the camera was ready, and then would disappear only to reappear as soon as we gave up. We tried sneaking around the side of the house, to find him beautifully posed against the white shingles. We hung beach towels out on the line as a blind and got a few shots that way, and July 19 we took the screen out of the back door and shot the rest of the roll. I remember the date because that was the last time we saw him. ----But this morning there was a little yellow-olive backed bird in the mimosa tree, probably a warbler but I haven't the vaguest idea which one.

P.S. On August 14th, a 'phone call from Marge Fischer reported that the white sparrow was again in the bird bath that morning. So - happy ending!


