

Join the Audubon Campaign

The National Audubon Society was organized at the turn of the century to stop the slaughter of plumed birds whose feathers were used to adorn ladies' hats. Working together, these early conservationists stopped the "plume hunters" and saved the birds from extinction.

Today a new breed of plume hunters, as short-sighted and self-seeking as ever, has declared war on environmental protection. Under the pretense of eliminating government waste and ending inflation, the Reagan Administration, led by Secretary of the Interior James Watt, is attempting to reverse two decades of progress in protecting our birds and other wild animals and the air, land, water, and forests on which all life depends.

To counter this attack, the National Audubon Society has launched an emergency Citizen Mobilization Campaign. You can join the campaign at no cost to yourself and at great benefit to your natural heritage.

Sign up and be kept informed. The Audubon Society will notify you of current threats to our air and water, wilderness and wildlife, parks and forests. And we'll let you know how you can help defeat the modern-day plume hunters.

Bureaucratic Brush-Off

The Hempstead Plains Preserve was once an extensive area of plains in central Nassau County. It was the easternmost true plains in the United States. Rare plants such as the Crows Foot Violet used to grow there. Upland Plover once nested there. Historically, the plains are often called the "Cradle of Aviation."

When Mitchel Field was given to Nassau County some of the land was set aside to preserve this heritage. Now development in the area threatens the Recently I wrote County Executive Francis T. Purcell and asked for the following information: 1. The exact size and location of the preserve, 2.A copy of the master plan for Mitchel Field and 3. Information on any biological or ecological studies being planned of the preserve.

Mr. Purcell's office replied saying I could call Commissioner Cacciatore of the Department of Commerce and Industry. He would answer my questions. When I called the Commissioner, he was at a conference and his secretary said he would call back. He never did. I wrote him a letter with my request. Again, he did not reply. I wrote a letter to County Executive Purcell complaining about Commissioner Cacciatore's lack of response. Mr. Purcell's office wrote back stating that they would see to it that the Commissioner answered.

Later in the week my wife received a call from the Commissioner. He said he did not "understand" what I wanted. My wife was not familiar with the situation. The next day my wife called back with my instructions. Once again, the Commissioner was not in. My wife did get to talk to his assistant, a Mr. Fitzgerald. He said that his department was too busy to answer my inquiries. We could get the information from the newspapers. He had better things to do than be bothered by us. We had no right to the information.

My wife then called Mr. Purcell's office and told Special Assistant Fred Hager what happened. He said that he would try to get as much information as he could. At this time I still have not received any of the requested information.

Local politicians tell us that development of Mitchel Field will increase tax revenue and provide jobs. Environmental problems, they claim, could easily be solved. If this is so, they should be proud of the plan. should think they would be bragging about it. Instead, they refuse to give any information to the public. Are they hiding something? Why hasn't the County Executive's office handled the matter directly? Are they trying to separate themselves from the prob-Why doesn't the Commissioner answer the inquiry as the County Executive's office says he will?

The article on Gypsy Moth control Note: published in the October Skimmer did not imply that anyone at South Shore Audubon is in favor of pesticides. So far as we know, the programs being considered do not involve the use of pesticides.
